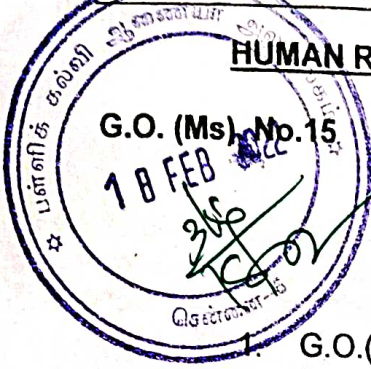

**ORDER:**

In the Government Order first read above, orders have been issued for Revision of Syllabus and Scheme of Departmental Examinations based on the recommendation of the Departmental Examinations Reforms Committee.

2. In the letters second read above, the Director of School Education has stated that in the Special Rules for the Tamil Nadu Ministerial Service in Annexure IV, Annexure V and Annexure IX-T, the Departmental Tests prescribed for Superintendents / Head Clerks / Accountants / Assistants of the School Education Department are as follows:-

1. Account Test for Sub-ordinate Officers Part - I
2. District Office Manual Test (Now Tamil Nadu Government Office Manual Test)
3. Deputy Inspectors Test (3 papers)

3. He has further stated that the Tamil Nadu Public Service Commission in its notification dated 23.09.2017 has deleted the Departmental Test of School Education Department namely "Tamil Nadu School Education Department Administrative Test Paper III - Educational Statistics" in pursuance of the orders issued in Government Order first read above and the said test was not conducted since December 2017.

4. In this regard, he has requested the Government to delete the Departmental Test "Tamil Nadu School Education Department Administrative Test Paper III - (Educational Statistics)" and to issue necessary amendment to the Special Rules for Tamil Nadu Ministerial Service.

5. The Government have examined the above proposal in detail and decided to issue consequential amendment to the Special Rules for the Tamil Nadu Ministerial Service.

6. The following notification will be published in the Tamil Nadu Government Gazette.

### NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Ministerial Service (Section 22 in Volume III of the Tamil Nadu Services Manual, 2016).

2. The amendments hereby made shall be deemed to have come into force on the 2<sup>nd</sup> March 2017.

### AMENDMENTS.

In the said Special Rules,

(1) in Annexure IV, under the heading "Tests to be passed or Training to be undergone before promotion", in the tabular column, under the sub-heading "School Education Department", against the entry "Superintendents, Head Clerks, Accountants and Assistants" in column (1), for item (i) Deputy Inspector's Test in column (2), the following item shall be substituted, namely:-

" (i) Tamil Nadu School Education Department Administrative Test – Paper – I – Higher Secondary / Secondary / Teacher Training and Special Schools; and

Tamil Nadu School Education Department Administrative Test – Paper II – Elementary/Middle and Special Schools;";

(2) in Annexure V, under the heading "Tests to be passed, training to be undergone or other qualification to be acquired by persons appointed in the service:", in the tabular column, under the sub-heading "School Education Department", against the entry "(i) Head Clerks and Assistants" in column (1), for the expression "Deputy Inspector's Test" in column (2), the expression "Tamil Nadu School Education Department Administrative Test – Paper – I – Higher Secondary / Secondary / Teacher Training and Special Schools, Tamil Nadu School Education Department Administrative Test – Paper II – Elementary/Middle and Special Schools" shall be substituted;

(3) in Annexure IX-T, in rule 8, in sub-rule (b), for item (i) Deputy Inspectors Test, the following item shall be substituted, namely:-

"(i) Tamil Nadu School Education Department Administrative Test – Paper – I – Higher Secondary / Secondary / Teacher Training and Special Schools; and

Tamil Nadu School Education Department Administrative Test – Paper II – Elementary/Middle and Special Schools."
