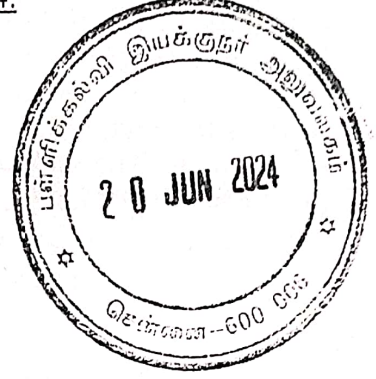

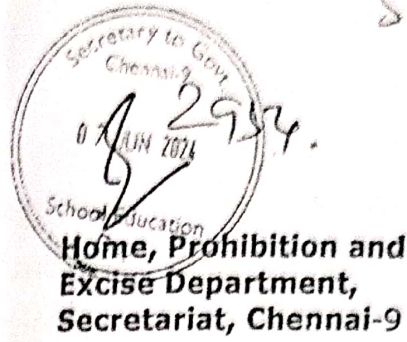

I invite your attention to the reference first cited, wherein it has been requested to offer the remarks on the proposal of the Additional Director General of Police (EB), Chennai seeking orders for formation activities and monitoring of Anti-Drug Clubs and the Volunteering Programme for NSS/NCC/YRC/RRC volunteers, etc. under Drive Against Drugs to sustain anti-drug awareness amongst students.

2. In the reference second cited, it has been informed to this Department that the above said proposal is agreed to by your Department and accordingly instructions were issued to the concerned officials of your Department. Based on this, the Anti-Drug Clubs have been formed in all the Schools in the State and the same is functioning at present.

3. I state that while finalising the members for the District Level Committee and State Level Committee for both the Anti-Drug Club and Volunteering Programme for selection of best Clubs/Teams in the District Level as well as State Level, it requires further modifications in the Members of the Committees and it also requires some other modifications in the Time-Line of Events.

4. I enclose a revised proposal for formation, objectives, guidelines and monitoring for both the Anti-Drug Clubs and Volunteering programme and composition of the District Level Committee and State Level Committee with Time Line of Events in the Annexure to this letter.

5. I also state that the academic year 2023-24 is already over. It is proposed to distribute the District Level and State Level Awards to the best 3 Anti-Drug Clubs in Schools / Colleges and other Educational Institutions for their performance during the academic year 2023-24 and to fix the following time-line for distributing awards to the best Anti-Drug Clubs for the year 2023-24 as a special case. The Timelines are as given below:

- a) District Level proposals to be sent for State Level Awards before 15.07.2024.
- b) The State Level Committee will meet and finalise State Awards before 31.7.2024.
- c) The awards will be given away by the Hon'ble Chief Minister during the Anti-Drug Awareness Pledge Day in August, 2024.

6. I also state that in respect of Volunteering programme, the guidelines and programme details have not been finalised and communicated to Educational Institutions so far. I am, therefore, to request you to issue necessary instructions to the HODs under your control to create awareness about the Volunteering Programmes in all Schools in the State, immediately, so as to motivate students for Volunteering programme which

- The Volunteers are required to devote at least 30 hours to conducting both online and offline Drug Awareness related activities.
- The parent organization (O/o the Additional Director General of Police (EB-CID), Tamil Nadu) may be approached for further assistance and help.

IV. REPORTING:

- The Volunteers are advised to submit the 30 hours of drug awareness activities report with appropriate photographs one activity one photo (Photo should be Maximum 20 MB in JPEG or BMP formats) along with brief activities report in A4 size paper, font size -12 Times New Roman and maximum 30 pages. Same shall be verified and countersigned by faculty in charge of the unit.
- Faculty shall prepare a consolidated report in the following format:

FUNCTIONS OF THE VOLUNTEERING PROGRAMME VOLUNTEERING PROGRAMME FOR NSS/NCC/YRC/RRC VOLUNTEERS:

A volunteering program has been planned to involve National Service Scheme volunteers, National Cadet Corps cadets and volunteers of other such organizations in regular awareness activities against drug abuse on regular basis.

I. OBJECTIVES :

- To create mass awareness.
- To involve NCC and NSS Volunteers on a regular basis.
- To ensure regular and sustainable campaign against drug abuse.
- Active involvement of students though the campaign is directly targeting students but indirectly it will create awareness in the whole society.
- To create a volunteer force against drug abuse.
- To make it an annual and regular affair.
- To get the attention of the Media and add further traction to the campaign.

II. DURATION:

- Volunteers have to devote atleast 30 hours on activities to spread awareness against drug abuse.
- Youth enrolled in NSS/NCC/YRC/RRC etc., in the Higher Secondary Schools /Colleges and Universities in Tamil Nadu can apply for the volunteering program as a team. (The limit for team members - Maximum 100).

III. Volunteering process:

- Youth can enroll through these youth organizations.
- Volunteers may participate in teams. The team size may be maximum 100 members.
- The Drug Awareness activities should be approved by the NSS/NCC/YRC/RRC In charge officers at the academic Institutions.

FUNCTION OF THE ANTI DRUG CLUBS

Anti-Drug Clubs are required to be set up in every educational institution for creating awareness against drug abuse.

I. OBJECTIVES :

- Awareness amongst students regarding ill effects of drug abuse. Though most students know that drugs are illegal, there is no counter narrative amongst their social and peer group that insists that drug abuse is wrong in every ethical, moral and legal sense.
- To protect the students from the ever increasing threat of drug addiction by involving them as stakeholders. By making it a responsibility that students have to ensure that their campus is drug free, they would take larger responsibility for their school and surrounding society.
- Students would have a sense of participation in the campaign. Today's youngsters are falling prey to the menace of drug abuse because of lack of any other outlet for their energies, lack of confidence and urge to fit in / seem 'cool', as a result of depression and because they feel they may not get caught.
- Anti-drug awareness to motivate the institutions to declare themselves drugs free.
- Generate a sense of confidence amongst parents of students.
- A healthy and fit next generation.

II. LOGO:

Every educational institution having Anti-Drug Club shall put a board regarding the formation of Club like being done for NSS, NCC, etc., The board shall display 'Ennaku Vendam' logo and toll free number of helpline 10581 and 9498410581.

III. ACTIVITIES:

- These activities are preferred to be completed by the end of an academic year for each Club for all its Members or associative Clubs.
- Organising and participating in seminars with Guest Speakers
 - Local Medical Officer
 - Local Police Personnel
 - Local Administration Personnel
 - Other Experts
- Organising a poster / pamphlet competition and creating pamphlets with catchy slogans and phrases to be judged by prescribed institution committee and winners to be appropriately recognised.
- Distributing pamphlets in public places under the supervision of faculty in charge of club.
- Organising and visiting De-addiction Centres under supervision of faculty in charge of Club.
- Organising a visit to local Fire Station, Police Station, etc., Members should learn to draft a complaint to Police in case of any untoward incident.
- Organising walkathon to create awareness on drug abuse under supervision of Teachers.
- Organising Cycle Rally to create awareness on drug abuse under supervision of Teachers.
- Organising an Essay Competition within the institution on the theme of drug abuse to be judged by Institution Committee and to be sent to District Level Committee / DEO.
- Organising Institution level quiz on the theme of drug abuse.
- Creating a song on the theme of drug abuse.
- Creating a street play to create awareness on drug abuse and organising such plays in campus and other areas.
- Any other innovative method to create awareness.

IV. COMPOSITION OF THE CLUBS, FUNCTIONING and REPORTS:

- Every Educational Institution will have an Anti-Drug Club.
- Membership into the Club will be purely voluntary for all students from Class.9 onwards in Schools and all students in Polytechnic or Colleges.
- Minimum of 5 Members of the Club per Institution will be Office Bearers / Representatives.
 - If Head of the Institution is of the opinion that more representatives are needed to conduct the Club activities then suitable numbers may be increased and intimated to District and State Level Committees.
 - Procedure of electing / selecting Office Bearers :
 - Preferably the members of the Club may elect/select the 5 representatives. Once finalised, the list of representatives along with their address and contact number will be sent to DEO for onward transmission to State Committee.
- The Anti-Drug Club will undertake the activities that are stipulated but not limited to those listed out by the State and District Committees. So long as the activities are in line with the greater objectives of the 'Drive Against Drugs' Campaign and within the confines of the existing laws enforced in the State, such activities may be undertaken.
- It is encouraged that activities are showcased in Social Media and the concerned accounts of 'Drive Against Drugs' may be tagged so as to take note of the activities and the traction it has generated. Suitable hash-tags will be conveyed which can be used for each post from the Club.
- An annual report will be prepared by the representative and vetted by the faculty in-charge of the Club and the Head of the Institution and 2 copies will be sent to the CEO, one copy will be forwarded by the CEO to the State Committee.
 - The annual report will contain gist of all the activities that the Club has undertaken in the academic year.
 - The annual report will be sent as stipulated at the end of the academic year as stipulated.

- The Chief Education Officer will act as the Member Secretary and to convene the meeting.
- The District Level Committee will request for quarterly and half yearly performance from the Clubs and motivate / facilitate the activities of the Clubs in whatever ways possible. The District performance of the Clubs will be conveyed to the State Level Committee in the same quarterly and half yearly fashion.
- The District Level Committee will select Top 3 Best Schools / Colleges / Polytechnics at District Level and forwarding the one best Club in School / College / Polytechnic category to the State Level Committee for selecting the top 3 Clubs in the State Level.

First Prize	:	Rs. 15,000 Cash award along with certificate.
Second Prize	:	Rs. 10,000 Cash award along with certificate.
Third Prize	:	Rs. 5,000. Cash award along with certificate.
